## 10. Any other business

#### <u>US – Small Ruminant Rule</u>

The Board welcomed the announcement that US authorities had removed the small ruminant rule, which was initially introduced two decades ago, prohibiting the imports of lamb from the UK and other countries where scrapie had been identified.

Discussion took place with regard to the demand for sheep meat into the US market and other overseas markets in general given the current challenges facing the red meat sector and trade post Brexit and Covid. The Market Development Manager informed that HCC continued to work closely with the UK Export Certification Partnership (UKECP) and also engaged with the UK Governments on market access and trade matters.

The Board would be kept informed of any developments in terms of market updates and trade agreements and it was agreed to provide a list of priority countries in relation to market access on Sharepoint for information.
